NOVEMBER 2020

Public Safety

Marysville Fire Department:

- Calls for service are down 7% from last year. This may be due to citizens being too afraid to call for service. This is following a nation-wide trend of decreases in service calls.
- Chief McFalls, when attending a Marysville YMCA event learned that the Tulalip Tribes donated \$50,000 to the Marysville YMCA, to help at-risk youth.

Finance

- Cigarette sale and tax is slightly up and fuel tax is below average.
- Motion made and carried to adopt Resolution 2020-78 ratifying the transfer of funds from the Fuel Station account to the Liquor Store account in the amount of \$500,000.00.
- Motion made and carried to adopt Resolution 2020-79 approving the Year 2020 budget increase of \$2,000,000.00 for Cost of Goods for the Tulalip Liquor Store with funding to come from the Tulalip Liquor Store revenue.

Property Management

- Motion made and carried to adopt Resolution 2020-80 authorizing the Second Amendment with JJMD Inc. (Bob's Burger and Brew) be recommended to the Tulalip Tribes Board of Directors for approval.
- Motion made and carried to adopt Resolution 2020-81 authorizing the Lease Agreement with Gi Yeon Coung Lee dba Jackpot Teriyaki be recommended to the Tulalip Tribes Board of Directors for approval.
- Motion made and carried to adjourn the regular Quil Ceda Village Council meeting at 2:27pm.

DECEMBER 2020

- Marysville Fire District Monthly Report accepted.
- Tulalip Police Department Monthly Report accepted.

Finance

- Revenue exceeded expenses by 2.1 million.
- Cigarette sales increased in 2020 and fuel purchase is down.
- Motion was made and carried to adopt Resolution 2020-82 approving the 2021 QCV budget as presented.
- Motion was made and carried to adopt Resolution 2020-83 approving the transfer of \$4,200,000 from the tax bank account to the Quil Ceda Village main operating account to cover the 1st Quarter operating budget as listed.
- Motion was made and carried to adopt Resolution 2020-84 approving the Moss Adams Engagement Letter for Quil Ceda Village Government Audit for the 2020 audit in the amount of \$33,000, plus expenses, with funding to come from the 2021 Quil Ceda Village Operating Budget.
- Motion was made and carried to adopt Resolution 2020-85 approving the Moss Adams Engagement Letters for Compact Fuel Taxes audit, Compact for Cigarette Taxes audit, and Sduhubs audit for 2020 in the amount of \$34,500, plus expenses, with funding to come from the 2021 Quil Ceda Village Operating Budget.


