


Quil Ceda Village Business Updates





NOTES FROM THE SEPTEMBER AND OCTOBER 2020 VILLAGE COUNCIL MEETINGS

OCTOBER 2020

Public Safety

- Motion was made and carried to adopt Resolution 2020-66 approving the one (1) year Tribal Court Services Agreement with the Consolidated Borough of Quil Ceda Village for the 2021 calendar year in the amount of \$319.278.00 with funding to come from the 2021 QCV Public Safety Budget.
- Motion was made and carried to adopt Resolution 2020-67 approving the one (1) year Tulalip Tribes Attorney Services Agreement with the Consolidated Borough of Quil Ceda Village for the 2021 calendar year in the amount of \$120,750.00 with funding to come from the 2021 QCV Public Safety Budget.
- Motion was made and carried to adopt Resolution 2020-68 approving the one (1) year Tulalip Tribes Prosecutorial Services Agreement with the Consolidated Borough of Quil Ceda Village for the 2021 calendar year in the amount of \$236,928.00 with funding to come from the 2021 QCV Public Safety Budget.
- Motion was made and carried to adopt Resolution 2020-69 approving the one (1) year Police Department Service Agreement for the Consolidated Borough of Quil Ceda Village for the 2021 calendar year in the amount of \$2,751,028.00 with funding to come from the 2021 QCV Public Safety Budget.
- Motion was made and carried to adopt Resolution 2020-70 approving the one (1) year Marysville Fire District Service Agreement with the Consolidated Borough of Quil Ceda Village for the 2021 calendar year in the amount of \$609,889.00.

Marysville Fire Department:

- The Marysville Fire Department responded to 26 EMS related calls: 13 of those medical calls resulted in transportation.
- The Marysville Fire Department responded to 3 calls that were fire alarm related with no actual fires.
- The average response time in September was 8 minutes and 20 seconds.

Tulalip Police Department:

- The Tulalip Police Department conducted 40 traffic stop and responded to 27 suspicious vehicles
- Stats for crimes against people showed no remarkable changes during the month of September.

Administration Report

- Motion was made and carried to adopt Resolution 2020-71 authorizing the change in Quil Ceda Village Sales and Use Tax Rate from 8.6% to 9.3% effective January 2021.
- Motion was made and carried to adopt Resolution 2020-72 approving the one-year Tulalip Tribes Central Benefits Department Service Agreement for the Consolidated Borough of Quil Ceda Village for the 2021 calendar year.
- Motion was made and carried to adopt Resolution 2020-73 approving the one-year Tulalip Tribes Federal Corporation Service Agreement with the Consolidated Borough of Quil Ceda Village for the 2021 calendar year.
- Motion was made and carried to adopt Resolution 2020-74 approving the one-year Office of Budget and Financial Management Service Agreement for the Consolidated Borough of Quil Ceda Village for the 2021 calendar year.

Finance Report

- Cigarette sales and tax is slightly up while the fuel tax is below average.
- The Public Safety payments were sent with the exception of Marysville Fire.
- Motion was made and carried to adopt Resolution 2020-78 authorizing the transfer of funds in the amount of \$1,500,000.00 from the tax account to the main account for QCV.

Human Resources

Motion was made and carried to adopt Resolution 2020-75 approving the Holiday Closure from December 24, 2020 through January 1, 2021, with essential staff and business enterprises remaining open on the regular posted holiday hours.

Project Management

Motion was made and carried to adopt Resolution 2020-76 authorizing the Quil Ceda Village President to sign the Helix Design Group Contract in the amount not to exceed \$184,340.00 with funding to come from the Quil Ceda Village Car Wash Project Budget.

Property Management

Motion was made and carried to adopt Resolution 2020-77 authorizing the revised Third Amendment for Seattle Premium Outlets be recommended to the Tulalip Tribes Board of Directors for Approval.

SEPTEMBER 2020

Public Safety

Marysville Fire Department:

- The Marysville Fire Department responded to Quil Ceda Village 19 times in August which was down from an average of 25 responses per month.
- Chief McFalls says he looked at the annual average and they typically respond to an average of 25 calls per month.

Tulalip Police Department:

- The monthly statistics did not show any significant increase with the exception of Walmart, Seattle Premium Outlets, Home Depot and Cabela's are doing well.
- · Seattle Premium Outlets has closed their parking garages, which helps their asset management monitoring.

Finance Report

- The annual audit for calendar year 2019 is complete.
- Government expenses are near annual average after public safety expenses were paid last month, with the exception of Marysville Fire as their second half invoice will be expensed later this year.
- The gas pump upgrade is complete.

- Motion was made and carried to accept the 2019 Clean Audit Report from Moss Adams.
- Motion made and carried to adopt Resolution 2020-56, authorizing the opening of a business bank account and the purchase of a Certificate of Deposit in the amount of \$250,000 with Washington Trust Bank. Account signers amended.

Maintenance

Motion was made and carried to adopt Resolution 2020-57 approving the Stripe Rite contract in the amount of \$213,685 with funding to come from the 2020 Quil Ceda Village Maintenance budget.

Human Resources

- The government passed an amendment to the Employee Handbook allowing up to 4 hours leave for their employees to assist their children that have distance learning constraints.
- Motion made and carried to adopt Resolution 2020-58 approving the QCV Employee Handbook Amendment of Section 4:13:18 as presented.

Utilities

Motion was made and carried to adopt Resolution 2020-59 approving the Utilities Service Contract between Quil Ceda Village and Tulalip Utilities Authority as presented.

Property Management

- Motion was made and carried to to adopt Resolution 2020-60 approving the First American Properties Inc. Commission Agreement be recommended to the Tulalip Tribes Board of Directors.
- Motion was made and carried to adopt resolution 2020-61 approving the Third Amendment with CPG Partners. L.P. dba Seattle Premium Outlets be recommended to the Tulalip Tribes Board of Directors.
- Motion was made and carried to adopt Resolution 2020-62 approving the Lease Agreement with Washington and Dhillon Management, Inc. (Port of Subs) be recommended to the Tulalip Tribes Board of Directors.
