### February 2022

#### Public Safety & Justice

##### Marysville Fire District Monthly Report

- Chief McFalls explains there were (20) calls Jan 2022, (18) EMS, (11) Transport, Carbon, Service, Fire Alarm Commercial, (40 -50) calls in Village, slower start. Transport Data given to BOD & GM.

##### Tulalip Police Department Monthly Report:

- Chief Sutter explains the stats, 3-month CAD Calls, January theft stayed the same. Mel, requests to put meetings together for further improvements for the village safe guards for future potential businesses. Community Response Team is being created.

#### Administration

- Motion made to adopt Resolution 2022-09 approving the amendments to the Quil Ceda Village COVID-19 Leave and Employee Expectations and Safety Policy as presented.

#### Finance

- Expenditures under budget, Maintenance under, public safety is at 22% of budget, cash basis on majority of the report.
- Motion made to adopt Resolution 2022-10 authorizing the architect contract with Rice Fergus Miller, Inc. for architectural services on Project QCV-CP-22-003 for a not to exceed amount of \$212,888.00 with funding to come from the approved project budget.
- Motion made to adopt Resolution 2022-11 approving to close the above mentioned QCV Utilities Capital Projects and authorize the transfer of unspent funds in the amount of \$183,186 to transferred to the QCV utilities Capital Improvements Account.

### March 2022

#### Public Safety & Justice

##### Tulalip Police Department Monthly Report:

Chief Sutter provides an overview of the crime statistics for the first three (3) months of the year and explains that the crimes against property are unremarkable with no changes. For the month of March, Tulalip Police Department (TPD) has received 462 calls for service, which include vehicle prowls,

car theft, and hit and runs. There is no change with the theft rates at Seattle Premium Outlets. TPD continues to meet with SPO, Walmart, and other businesses within the Village to discuss employee safety and crime prevention. President Sheldon asks Chief Sutter if he is working on having officers maintain a presence in the Village or discussed how to improve community safety.

#### Finance

- Mark Sabo provides details for the monthly finance report for February. Tax income is pacing slightly below at 17%, Cannabis tax is at 133k below pacing but above last year. Fuel tax is 15% under budget. Hotel occupancy tax is up. The City of Marysville has increased their sales tax to 9.4%. Expenses are all under budget until we pay the annual Public Safety payments. Projects ongoing are Ebey Slough, Salish network upgrade at Port Susan. This report needs to be updated with our closed projects, and those are the MBR upgrade, UIC Channel, Effluent Discharge, and Sewer line and pump upgrades.

#### Utilities

- Motion made by Councilman Gobin to adopt Resolution 2022-12 approving the Utilities Services Agreement between the Consolidated Borough of Quil Ceda Village and the Tulalip Tribes Utilities Authority.
- Motion made by Councilman Gobin to adopt Resolution 2022-13 approving the two (2) year Waste Hauling Utilities Service Agreement between Tulalip Utilities Authority and the Consolidated Borough of Quil Ceda Village in the amount not to exceed \$325,000.00 annually.

### April 2022

#### Public Safety & Justice

##### Marysville Fire District Monthly Report

- In March 2022, the statistics show we may have reached the end of the pandemic because calls for service are back to pre-pandemic totals. The average response time increased, likely due to a train delay. One train delay can increase the response time significantly. Marysville Fire District is working closely with Tulalip Bay Fire, collaborating on how to service the Tulalip Community. Chief McFalls explains the service border is at 12th Avenue.

## NOTES FROM THE FEBRUARY - APRIL 2022 VILLAGE COUNCIL MEETINGS CONT.

### Tulalip Police Department Monthly Report:

- Officers have increased presence in the Village, moving from the Remedy Tulalip location to other retail locations within the Village. They continue to work with Seattle Premium Outlets, and other retailers, to discuss employee safety tips and asset management. Those meetings will occur regularly. TPD acquired a canine officer that specializes in narcotics-and will be paired with Officer Jordan Jira. TPD has an active Community Response team currently working on the MMIW(Missing and Murdered Indigenous Women) movement with the FBI on missing women from the Tulalip community.

### Administration

- Motion made by Councilman Shopbell to adopt Resolution 2022-14 approving the Change in Rate of Sales and Use Taxes imposed within Quil Ceda Village from 9.3% to 9.4% effective June 1, 2022.
- Motion to adopt Resolution 2022-15 approving the 2022 Quil Ceda Village Budget Amendment by increasing the overall budget from \$19,026,590.00 to \$19,267,513.99 for 2022 Legal Services expenditures, effective immediately.
- Motion to adopt Resolution 2022-16 approving the appropriation and use of Cigarette Tax funds held at Quil Ceda Village as a funding source for a portion of the 2022 Tulalip Bay Fire District 15 Agreement in the amount of \$896,091.00 to provide services to the Tulalip Tribes of Washington.

### Finance

- Motion to adopt Resolution 2022-17 approving the closure of the Tulalip Liquor Store Update Project and the transfer of funding, in the amount of \$155,914.64, to the Marine Drive Expansion (MDES) project.
- Motion to adopt Resolution 2022-18 approving the amendment of the list of account signers, electronic fund transfer and electronic platform administrator authorities with Salal Credit Union due to the change in the Board of Directors.
- Motion to adopt Resolution 2022-19 approving the amendment of the list of account signers, electronic fund transfer and electronic platform administrator authorities with the US Bank deposit accounts due to the change in the Board of Directors.
- Motion to adopt Resolution 2022-20 approving the amendment of the list of account signers, electronic fund transfer and electronic platform administrator authorities

with the Wells Fargo deposit accounts due to the change in the Board of Directors.

- Motion to adopt Resolution 2022-21 approving the amendment of the list of account signers, electronic fund transfer and electronic platform administrator authorities with the Wells Fargo investment account due to the change in the Board of Directors.
- Motion to adopt Resolution 2022-22 approving the amendment of the list of account signers, electronic fund transfer and electronic platform administrator authorities with the Washington Trust Bank account due to the change in the Board of Directors.
- Mark Sabo provides an overview of the finance report. The tax income from cigarettes is pacing below projections at 22 percent, and the fuel tax income is at 24 percent.
- Motion made to adopt Resolution 2022-11 approving to close the above mentioned QCV Utilities Capital Projects and authorize the transfer of unspent funds in the amount of \$183,186 to transferred to the QCV utilities Capital Improvements Account.

### Utilities

- Motion made by Councilman Shopbell to adopt Resolution 2022-23 approving Quil Ceda Village Utilities to transfer from 2020 Capital Budget Project MBR Treatment Plant Security System Project (SEC) to 2022 Capital Budget in the amount of \$175,000 to be used as intended.

### Property Management

- Motion to adopt resolution 2022-24 approving the Recommendation for Authorization for Execution of Lease Agreement to the Tulalip Board of Directors for the execution of a Commercial Lease Agreement between the Tulalip Tribes of Washington ("Landlord") and Salish Sky Distribution ("Tenant") for 8825 34th Ave. NE Suite E Tulalip, Washington 98271 ("Premises").
- Motion made by Councilman Shopbell to adopt Resolution 2022-25 approving the Boeing Site Drainage Repair QCV-CP-21-006 TERO Fees with funding to come from the project budget.
- Motion made by Councilman Shopbell to approve resolution 2022-26 approving 8825 34th Avenue Northeast Suite F Improvement project funding in the amount of \$2,175.75 and funds to be utilized for TERO fees and project budget. Funding to come from 2019 QPark project budget as presented.
