AUGUST 2022

Public Safety

Tulalip Police Department Monthly Report:

- Motion made and adopted for Resolution 2022-53 approving the payment for the jail bill increase for 2022 and the transfer of \$1,150,000.00 from the Fuel Tax account managed by Quil Ceda Village on the Tulalip Tribes behalf to the Tulalip Tribes Key Bank Tribal main.

2023 Quil Ceda Village Fire Protection Discussion:

- The 2022 Fire Protection contract with Marysville Fire District expires on December 31, 2022, this is to inform the Council that we are entering into negotiations with Tulalip Fire District 15 to service Quil Ceda Village.

Administration

- Motion made and adopted for Resolution 2022-54 ratifying the sunset of the Quil Ceda Village Covid-19 Leave Policy and Employee Expectations with an effective date of August 8, 2022.

Finance

- The monthly finance report, through June, shows the cigarette tax is down at 3.6 million for the year, fuel tax is up slightly based on gallons sold, and the Hotel & Occupancy is below at 45%. The first half of the Public Safety payments are paid.
- Motion made and adopted for Resolution 2022-55 ratifying the transfer of funding in the amount of \$51,742.41 for the purchase of a bucket truck and the closure of the Salish Networks FIBER Capital Project
- Motion made and adopted for Resolution 2022- 56 approving the closure of the Salish Networks NWUP Capital Project and authorizing the transfer of the unspent funds in the amount of \$40,715 to the Quil Ceda Village Unspent Funds account.
- Motion made and adopted for Resolution 2022- 57 approving the closure of the Salish Networks ROUTE Capital Project and transfer of the unspent funds in the amount of \$1,560.85 to the Quil Ceda Village Unspent Funds account.

- Motion made and adopted for Resolution 2022- 58 approving the closure of the Right of Way on all roads within the 4th Street area Project and transfer of the unspent funds in the amount of \$52,257.19 to the Quil Ceda Village Fuel Tax Account.
- Motion made and adopted for Resolution 2022-59 approving the closure of the North Quil Ceda Boulevard Project and the transfer of the unspent funds in the amount of \$7,177.73 to the Quil Ceda Village Fuel Tax Account.
- Motion made and adopted for Resolution 2022-60 approving the retirement/severance pay for Thomas Williams for 14 years and 5 months of service to Quil Ceda Village in the amount of \$4,325.00.

Property Management

- Motion made and adopted for Resolution 2022-61 approving and authorizing Contract Amendment No. 2 to the architect contract with Helix Design Group for the Quil Ceda Village Car Wash Project for additional service work with an aggregated total in the amount not to exceed \$426,274 with funding to come from the QCV Car Wash Project Budget.
- Motion made and adopted for Resolution 2022-62 approving the recommendation of authorization to the Tulalip Board of Directors approving the Ground Lease regarding 4.68 acres of the western portion of the 6.5 acre parcel located between Home Depot and Cabelas between the Tulalip Tribes of Washington and CarMax Auto Superstores, inc. on the terms contained therein.

SEPTEMBER 2022

Public Safety

Marysville Fire District Monthly Report:

- During the month of August, Marysville Fire responded to calls in the Village 56 times, 43 of those calls were EMS related and 17 of those calls resulted in transport. The average response time was 9 minutes, 6 seconds. The district is looking at adjusting our staffing needs and transition from part-time to full-time, looking into approve new levies to offset the increased cost needed to support the staffing transition, and to support

building a new firehouse. The Council asked if calls for service are included in their decision to build a firehouse in certain areas more than others. Yes. Also included is the response time. The District has a goal of 5 minutes or less to respond to calls because there are challenges to life support as the time increases from 5 minutes. In addition to that update, the District will meet with GM Napeahi to discuss the 2023 Service Agreement.

Tulalip Police Department Monthly Report:

- Chief Sutter provides an overview of the crime statistics and report by first pointing out the color coding system in the report, and the difference between theft and shoplifting. Councilman Shopbell asked Chief Sutter if he is working with staff to create new strategies to combat the theft and increase public safety within the Village.

Administration

- Motion made & adopted for Resolution 2022-63B approving the Revocable License and Tolling Agreement between the Tribes and the Boeing Company.
- Motion made & adopted for Resolution 2022-64 authorizing the General Manager of Quil Ceda Village to execute a letter of intent to explore increasing the level of services and quality of response times for public safety issues within the Quil Ceda Village.
- Motion made & adopted for Resolution 2022-65 approving the Munis Upgrade Project, Tyler Software-as-a-Service, authorizes the reallocation of Capital Project funding from the Quil Ceda Village INFOR Licensing funding in the amount of \$75,466.67 to the Munis Upgrade Project, and approves the request for funding in the amount of \$82,015 from the Systems Implementation Project.
- Motion made & adopted for Resolution 2022-66 approving the Tulalip Market Budget Amendment for Cost of Goods Sold and Expenses related to Cost of Goods Sold in the amount of \$7,983,120 with funding to come from the Increased Sales Revenue.
- Motion made & adopted for Resolution 2022-67 approving the Marine Drive Budget Amendment for Cost of Goods Sold and Expenses to Cost of Goods Sold in the amount of \$5,757.90 with funding to come from the Increased Sales Revenue.
- Motion made & adopted for Resolution 2022-68 appointing Martin Napeahi as the Project Manager for the Tulalip Gaming Organization Christmas Lights Project and requests the transfer of \$2,300,000.00 for the project.

- Motion made & adopted for Resolution 2022-69 approving the Temporary Liquor Store Project Budget and acceptance of the transfer of funding from the Tulalip Tribes' Economic Development Reserve Funds in the amount of \$1,000,000.00 for the Temporary Liquor Store Project.
- Motion made & adopted for Resolution 2022-70 authorizing the reallocation of QCV Unspent funds in the amount of \$180,000 for the Temporary Ice Rink Event.
- Motion made & adopted for Resolution 2022-71 approving the Independent Contract Agreement with Robert Half Technologies Inc., in the amount of \$120,000.00 with funding to come from the 2022 TDS Operating Budget.

Human Resources

- Motion made & adopted for Resolution 2022-72 approving the retirement/severance pay for Douglas Goodman for 16 years of service to Quil Ceda Village in the amount of \$4,800.00.

October 2022

Public Safety & Justice

- During the month of September, Marysville Fire responded to calls in the Village 42 times, 43 of those calls were EMS related and 18 of those calls resulted in transport. The hunt for a new fire chief is underway. The application deadline is at the end of October but if there are no qualified candidates, we will advertise again. For your information, with the Marysville Public Safety Building closure, our administration will be moving to 64th and Grove. Councilman Shopbell asks if that will result in any response delays, and Interim Chief Neuhoft replies no- only our administration is moving. Marysville Fire met with the QCV General Manager for 2023 contract negotiations.

Administration

- Motion made and adopted for Resolution 2022-73 ratifying the QCV-Walker Inc. Agreement in the amount of \$1,627,086.50 with funding to come from the Christmas Lights Project budget.
- The Council asked if there is a traffic control plan in place for this event and if there is a hard opening date. Staff replies that the lights will be ready the week of Thanksgiving and that they are working with the Tulalip Gaming Organization on the traffic plan. The Council asks that the traffic control plan includes pedestrian safety.

Finance

- We are at nine months and/or seventy-five percent of the year. Tax income from cigarette sales is down about four hundred thousand from last year. Cannabis tax is above last year, but pacing under budget at sixty-six percent. During 2022 budget preparations, we did budget those tax dollars aggressively. Fuel tax, which is based on volume, is up about three hundred thousand from last year. Our expenses are showing below pacing, and that is based on timing. We have several departments experiencing employment issues and the public safety payments will catch us up. For Projects, we will close some projects out, Utilities has an open project for security. Any unspent funds from completed projects will be transferred and approved by resolution when we are ready.
- Motion made and adopted for Resolution 2022-74 approving the recommendation for authorization to execute the Public Utility District No. 1 Utility permit for the NW Quarter of Section 20, Township 20 North, Range 5 East, Willamette Meridian, and Snohomish County, Washington and depicted on Exhibit A.
- **Question:** Brian Carroll asks if there is an address for this meter yet, and further asks if staff can include the address in the future. Staff replied, there is no address yet. Once the project is complete and a meter goes live, an address will be provided. That address will be disseminated upon completion of the project.
- Motion made and adopted for Resolution 2022-75 approving for recommendation the commercial lease agreement regarding 8825 34 th Avenue NE STE H-1 between Tulalip Tribes and the Tenant for an initial term of five years as presented.
- Motion made and adopted for Resolution 2022-76 approving the assignment and amendment regarding 8825 34th Avenue NE STE I between Garret Dhillion dba Dhillon Management and assigns the Lease for Suite I to Harpreet Singh dba TR Sandhu as presented.
- Motion made and adopted for Resolution 2022-77 authorizing the execution of a contract with Choosing A Service and authorizes the QCV General Manager to sign this contract agreement in the amount Not-to-Exceed amount of \$131,328.92 with funding to come from the QCV Maintenance Budget.

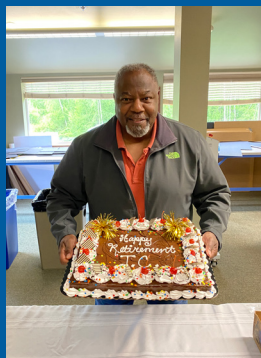
