### PROJECT UPDATE

If you've been wondering about the construction along 27th Avenue and 88th Street, wonder no more! The work that took place right in front of the Quil Ceda Village admin offices is part of a multi-step project aimed at installing and connecting sewer lines from the new casino to the Tulalip-owned treatment plant.

This project, along with additional work along Marine Drive, will connect sewer lines from the 4th Street area all the way to Quil Ceda Village. Performed by tribal contractor, Reece Construction LLC, the project will provide future sewer services for the opening of the new casino.

# Council Meeting at a Glance

## NOTES FROM THE COUNCIL MEETING

*Following are summaries of reports given during the October 2019 Quil Ceda Village council meeting*

### Public Safety Report

Motion was made and carried to adopt the following resolutions for the 2020 calendar year with funding to come from the yet-to-be-approved 2020 QCV Public Safety Budget:

- Resolution 2019-48 approving the one-year Tribal Court Services Agreement with the Consolidated Borough of Quil Ceda Village in the amount of \$319,278.00.
- Resolution 2019-49 approving the one-year Tulalip Tribes Attorney Services Agreement with the Consolidated Borough of Quil Ceda Village in the amount of \$120,750.00.
- Resolution 2019-50 approving the one-year Tulalip Tribes Prosecutorial Services Agreement with the Consolidated Borough of Quil Ceda Village in the amount of \$236,928.00.
- Resolution 2019-47 approving the one-year Police Department Service Agreement for the Consolidated Borough of Quil Ceda Village in the amount of \$2,751,028.00.

### Tulalip Police Department

*Given by Chief Chris Sutter*

- The Tulalip Police Department continually communicates with Walmart, Cabela's and Seattle Premium Outlets to discuss concerns and offer safety tips.
- Chief Sutter has offered additional security presence as needed for the Seattle Premium Outlets upon the signing and funding of the Additional Security Contract.

- The Tulalip Police Department is working with the Tulalip Tribes Community Health Department to organize a volunteer community cleanup event.

### Marysville Fire District

- Responded to 55 calls in the month of September
- 95% of calls were for Emergency Medical Services
- Average response time: 8 min, 51 seconds

Motion was made and carried to adopt the following resolutions for the Consolidated Borough of Quil Ceda Village for the 2020 calendar year:

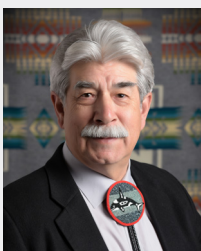
- Resolution 2019-51 approving the one-year Office of Budget & Financial Management Service Agreement.

### Human Resources Report

- Motion was made and carried to approve the request for Retirement/Severance pay for Lynn Jones for 10 years, 5 months, and 13 days of service to Quil Ceda Village. Thank you, Lynn!
- HR Manager, Marcia Horne, discussed adding a PolicyTech section to the Quil Ceda Village employee handbook. The Council directed staff to send proposed handbook changes to the board for review and to schedule a meeting to discuss further.

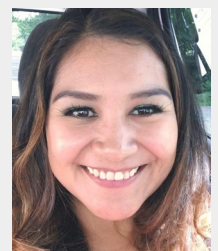

# Council Meeting at a Glance

## Finance Report

- Motion was made and carried to adopt Resolution 2019-54 authorizing the transfer of \$4,325,388.00 from the tax bank account to the Quil Ceda Village main operating account to cover the unfunded 2018 expenditures for the Quil Ceda Village governmental departments.
- Motion was made and carried to adopt Resolution 2019-55 authorizing the 2019 3rd Quarter Tax Transfer from the QCV Tax Account to the QCV Main Operating Account to cover the 3rd Quarter operating budget for the departments listed in the amount of \$3,551,250.00.
- Motion made and carried to adopt Resolution 2019-56 approving additional funding in the amount of \$15,500 for the Tulalip Liquor Store remodel project with funding to come from unspent funds from QCV.

## Tulalip Data Services Report

- During the month of September, eight sUAS flights were conducted to capture video and photos of the QCC Casino site, Gathering Hall, and Marina Sites.
- On September 8, 2019, one drone was damaged due to weather-related issues. There was no damage to any persons or personal property.

## Project Management Report

- Motion was made and carried to adopt Resolution 2019-57 approving Contract Amendment No.5 for Tulalip Liquor Store Update Project with Helix Design Group, Inc. in the amount of \$7,782.00 and authorizing the Quil Ceda Village Council President or Quil Ceda Village General Manager to sign the contract as presented.
- Motion was made and carried to adopt Resolution 2019-58 Change Order No.003 to the contract with Reece Construction LLC with no additional cost to the Contract for the MBR Facility Upgrade Project Budget.

## Property Management Report

- Motion was made and carried to adopt Resolution 2019-59 approving the Tulalip Nails Lease Cancellation and Termination Agreement and recommends it to the Tulalip Tribes Board of Directors for approval.
- Letters of Intent have been received for PHO Restaurant and Sharetea.
