NOTES FROM THE DECEMBER 2019 COUNCIL MEETING

Following are summaries of reports given during the December 2019 Quil Ceda Village council meeting.

Public Safety Report

Marysville Fire District

Given by Chief McFalls

- Responded to 46 calls in the month of November
- 44 calls were medical-related
- Average response time: 8 min, 26 seconds

Tulalip Police Department

Given by Chief Sutter

- Walmart and Cabela's increased patrols for the month of November.
- Crimes against people were down compared to October.
- Property crime increased this month - likely due to extra visitors and seasonal shoppers.
- Motor vehicle accidents increased slightly over last month.
- Chief Sutter will liaise with the new Seattle Premium Outlets general manager and other lessees.
- New recruits will be sworn in.

Finance Report

Given by Mark Sabo

- Quil Ceda Village has earned 92% of expected revenue which is right on budget.
- After payment of the second half of the Public Safety expenses, Quil Ceda Village will be pacing under budget for expenses.
- At the end of 2019, Revenue is expected to be on target, and expenses are expected to be \$1.5 million under budget.
- Tulalip Liquor Remodel project is to be completed in January 2020.
- Motion was made and carried to adopt Resolution 2019-64 approving the Quil Ceda Village Operating & Capital Budget Expenditures in the amounts of: \$18,024,163 for Quil Ceda Village Government, \$61,798,444 for Quil Ceda Enterprises, and \$12,502,000 for Government and Enterprises Capital Expenditure.

- Motion was made and carried to adopt Resolution 2019-65 ratifying the transfer of funds from Tulalip Broadband to Salish Networks in the amounts of \$100,000 and \$88,376.77 on October 29, 2019.
- Motion was made and carried to adopt Resolution 2019-66 ratifying the transfer of funds from the Fuel Tax account to the Tulalip Tribes for the contract with Parametrix for 4th Street and 88th Street I-5 Corridor in the amount of \$2,531,855.02.

Human Resources Report

Given by Khia Grinnell

Motion was made and carried to adopt Resolution 2019-67 approving amendments to the Quil Ceda Village Employee Handbook as presented, and effective January 1, 2020. Amendments to the handbook include:

- The use of PolicyTech which allows easy access to the handbook and department policies and provides read receipts.
- Mandated reporter language so all employees of Quil Ceda Village become mandated reporters.
- Call-in requirements.

Utilities Report

Given by Jerome Gobin

- Motion was made and carried to adopt Resolution 2019-68 approving the use of funds from the Quil Ceda Village Utilities 2019 Capital Budget funds Effluent Discharge Engineering for the Underground Injection Channel Improvement project. This resolution reallocates funds to complete the Effluent Discharge Engineering project and corrects the discharge issues. The project should be completed by April and have EPA approval in June 2020.
- Motion was made and carried to adopt Resolution 2019-69 approving the one-year service agreement between Quil Ceda Village and Tulalip Tribes Utilities Authority District 1 in the amount of \$275,000 with funding to come from the 2020 Utilities Budget.

Tulalip Data Services Report

Given by Jacob Setterberg

- During the month of October, 12 sUAS flights were requested; ten flights were completed; and two flights were canceled due to firmware issues. The purpose of these flights was to capture video and photos of the QCC Casino site, Gather Hall and Marina Site, Mission Beach Cemetery, and Tulalip Bay Phase III.
- During the month of November, 22 sUAS flights were requested; 21 flights were completed; and one flight was canceled due to battery issues. The purpose of these flights was to capture video and photos of Quil Ceda Village area, QCC Construction site, Gathering Hall and Marina site, Tulalip Bay Phase III, and various beaver relocation sites.

- Beginning in 2020 Natural Resources will be billed for beaver relocation flights.

The public is encouraged to attend Quil Ceda Village’s monthly council meetings, located at 8802 27th avenue NE Tulalip. Upcoming meetings are scheduled for Tuesday, February 18 at 1 pm and Monday, March 16th at 1 pm. For more information, contact Village Manager, Martin Napeahi, at 360-716-5000.
